The Bay of Bengal Programme Inter-Governmental Organisation (BOBP-IGO) **has received a grant (TF 018233)** from the **International Bank for Reconstruction and Development** toward the cost of **“Ocean Partnership for Sustainable Fisheries and Biodiversity Conservation – Models for Innovation and Reforms: Bay of Bengal Project”**, and it intends to apply part of the proceeds of this grant to payments under the agreement(s) resulting from this IFB for purchase of Plywood and Wood timber for Installation of Insulated Fish Boxes in thirty numbers traditional type FRP boats with OBM in Jalari Palem hamlet, Pudimadakka Panchayat in Achutapuram Mandal, Visakhapatnam District, Andhra Pradesh.

Bidding will be conducted using the Shopping Method specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits and is open to all Bidders as defined in the Guidelines that meet the following minimum qualification criteria:

- Registered Company in India with minimum three years of business experience.
- Having proper PAN and TIN and GST Number

Bids must be delivered to the address below only by **Hand/Post/Email** at or before **1700 Hours on 19 December 2017**. Late bids will be rejected. Bids will be opened in the presence of the Bidders or their representatives who choose to attend at the address below at **1500 Hours on 22 December 2017**

**PRICE TO BE QUOTED IN INDIAN RUPEE ONLY**

Validity of Quotations: the quotation shall remain valid for a period not less than 45 days after the deadline fixed for submission of quotations.

Each bidder must submit only one quotation.

Items should be supplied at Visakhapatnam.

**Valuation of quotations and Award of contract:**

**Evaluation of the quotes will be done based on cost of requested items. The contract will be awarded to lowest cost bidder.** The purchaser prior to the expiration of the quotation validity period will notify the bidder whose quotation is accepted for the award of contract. The terms of the accepted offer shall be incorporated in the purchase order. Payment shall be made within 45 days of the delivery of the goods and their acceptance.

**Notwithstanding the above, the purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of the contract.**
